declare that the statement made below are true to the best of my knowledge and information: -

1. I understand that only a limited number of rooms for accommodation are available in the hostel.
2. I understand that the hostel is provided to students based on the rules and regulations of the Dean Student Welfare office.
3. Hostel accommodation will be allotted only after payment of Rs. 14,000/- (Rupees Fourteen Thousand) for UG students and Rs. 45,000/- (Rupees Forty-five Thousand) for PG students in advance through SBI Collect (<https://www.onlinesbi.sbi/sbicollect/icollecthome.htm> – Educational Institutions). (Annual hostel fee: Rs. 7,000/- for UG and Rs. 15,000/- for PG).
4. I declare that I shall not dine outside under any circumstances since the mess is compulsory for hostel inmates of the institution during my study period.
5. I also undertake that in the future I will not deny any change of accommodation from one hostel to another or from one room to another if allotment is renewed.
6. Any acts of indiscipline such as aggressive behaviour, possession or consumption of prohibited substances (i.e., alcohol etc.), damage to the property of the college or hostel, or indulging in assault shall invite strict action and may result in rustication for a period of six months.
7. The hostel gate will be closed by 9:00 PM for UG students and 10:00 PM for PG students. In case of emergency, I shall contact my hostel wardens.
8. I have read the rules and regulations of hostel accommodation and shall abide by the same. Expulsion from the hostel would mean automatic confiscation of the paid hostel dues.
9. I will not keep any vehicle in the hostel premises. (For UG students only).
10. I will not use electrical appliances (Induction Plate, Heater, Refrigerator & AC) in the hostel. If found, I shall pay a penalty charge of Rs. 10,000/- or my NOC will be put on hold.
11. I will give prior information to the hostel superintendent before leaving the hostel.
12. Ragging is a punishable offence as per the directives of the Hon'ble Supreme Court of India and the Raghavan Commission recommendations. Any student involved in ragging shall be liable for permanent expulsion from the Institution.
13. Students must return to their respective hostels within 30 minutes after classes are completed.
14. I understand that it is mandatory to provide my and my Parents active WhatsApp number to the DSW office. In case of any change or discontinuation of the number, I shall immediately inform the DSW office. This information will also be updated in the Hostel Allotment Form and the Affidavit.
