NOTICE INVITING TENDER FOR OUTSOURCING OF MANPOWER AT RIMS, RANCHI

Due to single qualified bidder the tender no. 322 dated 20.01.2016 is being cancelled and re-tender is invited through sealed offers in two bid system (1st Terms & Conditions Part i.e. documentation part 2nd Price bid) by Speed Post/Registered Post only, from competent agencies to provide experienced, qualified and competent manpower such as – Paramedics, Nursing Staffs, Various 3rd Grade & 4th Grade Staffs for hospital grade jobs at Rajendra Institute of Medical Sciences, Ranchi. Tenders will not be accepted by hand or any other agency.

- (5) Annual turn over of the bidding company for last three years duly signed by chartered accountant having minimum annual turn over of Rs. One Crore. The supporting balance sheet must be attached with the tender.
- (6) Unique I.D. Card of the owner or directors of the bidding agency (which ever is applicable)

Other terms & Conditions of the tender

- (1) The bidders have to provide the required manpower within seven days from the date of issue of work orders.
- (2) If there will be found incompetency in the works of the manpower (provided by the bidder) then RIMS authority shall have the power to terminate the specified manpower from the work immediately, or in worst case the agency may be terminated from the works.
- (3) The provided manpower shall be under 60 years age. For proof of age the bidders have to provide the certificate of age proof (i.e UID card / Driving Licence / Educational Certificate etc.)
- (4) The works will be awarded on six monthly basis. It may be extended as per performance and mutual understanding or need of RIMS.
- (5) In case of non functioning or malfunctioning or malpracticing or non obedience of the outsourced workers, monetary penalty may be implemented / payment may be deducted @Rs. 200/- in each complaint case, if found correct by RIMS, authority.
- (6) Agency have to submit EPF/ESI Service Tax / any other taxes or levis on their own and on schedule time. The agency have to provide the challans or certificates issued by the competent authority regarding submission of above mentioned taxes & levis. RIMS will not made payments, if agency fails to submit the challan or certificate of the same in the next month after payment of first month
- (7) Payment from RIMS will be made on the basis of attendance provided by the concerned unit head / incharge of RIMS, Ranchi
- (8) The price bid of only those bidders will be opened who will qualify the required documentation part (i.e. technical part) of the bid. In lack of any document, demanded under tender, the bid will be rejected at the time of technical evaluation.
- (9) RIMS authority shall have power to reject or accept any or all the tenders without assigning any reason.
- (10) The bidder have to provide Identity card & proper uniform to their manpower by their own. RIMS shall not pay extra for the above.
- (11) The bidder have to submit two bids (i) Technical or documentation bid with all the documents & EMD & (ii) Price part having only price component.
- (12) The matter/arbitration, if any, arises in this tender / work, then it will be under jurisdiction of Hon'ble Court, Ranchi.

- (13) It shall be lawful / power of the undersigned to accept or reject any one or all the bids without assigning any reason.
- (14) Before execution of the works the bidders have to enter into an agreement with RIMS after getting the work order.
- (15) The bidders have to submit bank guarantee equal to 10% of the contract value before entering into agreement
- (16) The bidder have to confirm that the manpower deployed by them should bear good moral character. Address proof of the manpower deployed must be provided by the bidders to RIMS, Ranchi.
- (17) Rate / Price of the work force as per their post should be quoted on per day / per 8 hourly shift basis e.g :-

- (18) It shall be sole responsibility of the bidders to make payments to their manpower as per labour laws & also to follow the labour laws. If found guilty / faults, then penalty may be implemented on the agency as per decision of RIMS Authority.
- (19) All the pages of the tender/bid must be duly stamped & signed by the bidder and paging (Page Nos) must be done.
- (20) Compliance report of the tender:

 It is mandatory to fulfill all the required minimum criteria. In lack of any required document, the tender will be rejected directly at the time of technical evaluation.
 - All documents duly completed, signed and sealed should be enclosed with your tender offer failing which your quotation will be treated as incomplete.
