Delivery & Installation: The indegenous items shall be delivered within 30 days and imported items within 12 weeks of issue of supply order. The goods should be manufactured after adoption of latest technology.

Guarantee / Warrantee Period : For the equipment value upto Rs. 01 Lakh : The tenderers must quote for 2 years comprehensive warranty (ncluding all spares accessories and labour) from

the date of completion of the satisfactory installation. The warranty charges shall not be quoted separately otherwise the offer shall be summarily rejected. Guarantee / Warrantee Period : For the equipment value above Rs. 01 Lakh : The tenderers must quote for 5 years comprehensive warranty (ncluding all spares, accessories and labour) from the date of completion of the satisfactory installation.
