Failing which the above mentioned amount may be deducted from the bill amount against performance bank guarantee. Performance security shall be returned to the agency without any interest after completion of period (subjected to satisfactory performance certificate given by end user department).
- 7. Force majeure will be accepted on adequate proof thereof.
- 8. Material Life/ Expiry: Supply material should have ordinarily minimum 2/3<sup>rd</sup> of shelf life. (Minimum of the 2/3<sup>rd</sup> of the expiry period remaining on the date of receipt of items in concerned department of Blood Bank Long-expiry items should be given, Short-expiry items will not be accepted by the department hence, rejected and those will be supply-back the fresh items within the given time except in case of control which usually comes for 20-60 days expiry time. There are certain items which usually come with 6-8 months expiry at the time of delivery and can be consumed by the department within a month time can be used. Usually department issues the requisition for their requirement keeping next three month requirement, however they can take staggered supplies in case expiry matters most with the official intimation to the supplier.
