

ADDENDUM No. 02

This Addendum (hereinafter referred to as the "Addendum") to the Distribution Agreement dated 07th December 2021 (hereinafter referred to as the "Agreement") is made on this 19th March 2024.

By and Between

Becton Dickinson India Private Limited, a company incorporated under the Companies Act, 1956 having its registered office at 202-204, Tolstoy House, 15, Tolstoy Marg, New Delhi-110001 and its Corporate Office at 6th floor, Tower B, Signature Towers, South City-1, Gurugram, Haryana-122001 (hereinafter referred to as "BD" which expression shall unless be repugnant to context or meaning thereof, shall be deemed to mean its successors and permitted assigns) of the **FIRST PART**;

And

SHANTI STORES is registered under the laws of India and having its principal place of business at "08, LAXMI MANSION, MAIN ROAD, BISTUPUR, EAST SINGHBHUM, JHARKHAND, 831001." (hereinafter referred to as "DISTRIBUTOR" which expression shall unless be repugnant to context or meaning thereof, shall be deemed to mean its successors and permitted assigns) of the **SECOND PART**.

(hereinafter referred to as "the Distributor" which expression shall unless be repugnant to context or meaning thereof, shall be deemed to mean its successors and permitted assigns) of the **SECOND PART**.

(BD and the Distributor are hereinafter collectively referred to as 'Parties' and individually as 'Party'.)

Whereas BD had appointed the Distributor to distribute and supply BD products on terms and conditions more particularly agreed in the Agreement.

And whereas, the Parties are desirous of amending certain terms of the Agreement in accordance with the conditions agreed hereunder between the Parties.

NOW THIS ADDENDUM WITNESSETH AS FOLLOWS:**1. This Addendum:**

- a) Unless repugnant to the context, is interpreted according to and adopts the definitions, as specified in the Agreement.
- b) Is a part and parcel of the Agreement executed between the Parties pertaining to the subject matter of the Agreement; and
2. Shall come in to force from 29-Mar-2024 | 13:57 IST ("Effective Date").

3. The Parties hereby agree to amend Clause 4.6 of the Agreement and add/amend the following:

- A. Clause 4.6(c)(i) is amended to include the expression Health Care Institutions (Hospitals). The amended Clause 4.6 (c)(i) would be as follows:

"BD reserves the right to set pricing levels for the Products on government or Health Care Institutions or other tender contracts in the Territory and may at its sole discretion consult the DISTRIBUTOR on the same."

- B. A new Clause 4.6 (g) stated as below would be added to the existing clause 4.6 of the Agreement:

"(g) Discounts:

- (i) *The Distributor is authorized to provide discounts on Secondary Sales in the open market on BD's request on the goods sold to the Distributor under this agreement from time to time, and such discounts will be agreed between BD and the Distributor through approved discount forms clearly stating the parameters, quantum/percentage and validity of such discounts. To be clear, the expression "Secondary Sales" in the Agreement and this Addendum pertains to the sales the Distributor makes to healthcare institutions, which BD and the Distributor have agreed upon through approved discount forms.*
- (ii) *The distributor will from time to time submit the details of such discounts provided in the open market along with requisite documents as follows:*
- I. *Primary BD's tax invoice number against which goods were originally sold on which Discount is provided.*
 - II. *Relevant supporting documents such as tax invoices raised by the Distributor including the Purchase Order, Proof of Delivery, etc.*
- (iii) *All discounts must be submitted on or before the end of October pertaining to the previous financial year or as per timeline/notified prescribed under GST law.*
- (iv) *The Distributor acknowledges and undertakes that the input tax credit availed by it shall be reversed in accordance with applicable GST law, in case if GST credit note is issued by BD. The Distributor further undertakes to share with BD India appropriate declaration and any other supporting documents as may be required by tax authorities, to substantiate such reversal as and when requested by BD.*
- (v) *Based on the above details and subject to verification of the documents by BD, the discount claim will be settled by BD by issuing discount credit notes to the Distributor."*

C. The expiration date stated in the Agreement will stand amended, and the current expiration date in the Agreement shall be replaced with a new expiration date of 31 December 2025. As a result, the agreement shall expire on 31 December 2025.



4. Savings
