### Eligibility Criteria:

1. Common Bio- Medical Waste Treatment Facility (CBWTF) must be approved by Jharkhand State Pollution Control Board (JSPCB).
2. CBWTF should be located within a radial distance of 75 Kms from RIMS, Ranchi.
3. CBWTF should have permission for handling the Bio-Medical Waste in Ranchi district.
4. The rate for work should be as per the latest decision made by Jharkhand State Advisory Committee for Bio- Medical Waste Management.
5. CBWTF should have at least 3 years working experience in the handling of Bio- Medical waste.


### General Term and Conditions:

1. CBMWTF has to meet all the rules and regulations (including amendments) stipulated by JSPCB.
2. Facility will be liable for any violation of Bio-Medical Waste Management Rules 2016 (and amendments). Environmental (Protection) Act 1986 and relevant rules made there under after collection of Bio- Medical waste from RIMS, Ranchi.
3. Facility has to transport segregated waste in closed container vehicle to its treatment facility in enclosed Bins.
4. Facility must ensure unloading the bio- Medical waste at the facility site only. Not in Mid Way.
5. Facility has Bar Coding and Global Positioning System (GPS) for handling Bio-Medical waste.
6. Facility will be responsible for disposal of treated waste into secured landfills, Treatment Storage and Disposal facility (TSDF) or recycling plant applicable as per schedules of Bio- Medical Waste management rule 2016.
7. All papers of the EOI should be signed and stamped by authorized signatory of CBWTF.
8. The RIMS, Ranchi has right to cancel EOI at any stage. Any kind of dispute will be resolved amicably and in this connection the decision of RIMS, Ranchi will be final.




