Terms and Conditions

1. Work will be allotted for One (01) year and it may be extended further based on performance and approval of competent authorities of RIMS, Ranchi.
2. If there will be any change in government policy on the rate of uniform exchange value of Rs. 1600 per liter of plasma, then the company will be bound to provide the revised exchange value.
3. Agency/vendor shall arrange for pickup of surplus plasma from blood centre, RIMS, Ranchi. Freight and octroi expenses arising on account of transportation of surplus plasma shall be solely borne by the agency/vendor.
4. The agency/vendor must provide undertaking to fulfil needs of Indian market first and none of products recovered from the Indian plasma should be exported before fulfilling domestic demand.
5. The Company /vendor should have at least 7 years of experience of receiving surplus plasma from any 3 reputed government institutes/hospital (copy of work order should be submitted).
6. The Company/vendor should have a license of maximum products.
7. The company/vendor should have 7 years experience of plasma fractionation.
8. Successful agency/vendor awarded the contract must get an agreement signed with terms and conditions mentioned in the EOI on a Rs.100 non-judicial stamp paper before work order can be issued in relation to collection of surplus plasma.
9. Security deposit is to be submitted as performance guarantee; in case of any irregularities RIMS authorities can deduct penalty charges. It will be returned once contract duration is over.
